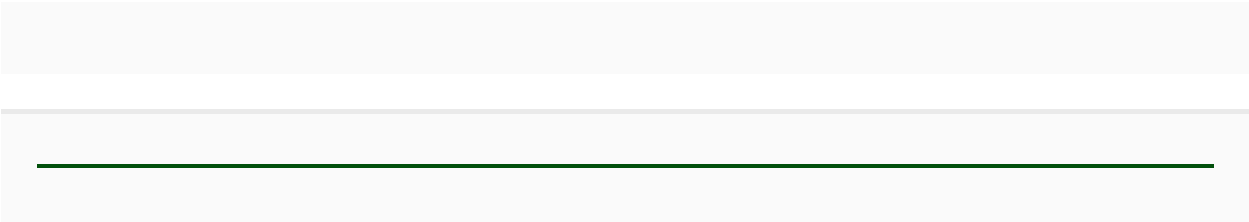

**COMMUNITY UPDATE: STAND WITH FRIENDS OF SOUTH CARTHAY AGAINST  
CARMEL PARTNERS' TOWER PROPOSAL**

Carmel Partners' plan for a towering 28 story apartment complex at 1050 La Cienega Blvd. has been met with strong opposition from our community. Last October, nearby residents formed an unincorporated association called **Friends of South Carthay ("FOSC")** to oppose the project as currently proposed and have filed legal appeals, so far rejected by the city. While the city has given its initial approvals to the project, FOSC has been tirelessly fighting against the proposal through community outreach as well as legal action.

FOSC along with CD-5 Councilmember Yaroslavsky have secured some concessions, such as a reduction in height of the proposed tower to 24 stories and other minor mitigations. However, we believe there's much more to be done to preserve the unique character of our beloved neighborhood.

FOSC is actively seeking funds to continue the community's legal challenge and to achieve more substantial modifications to the project. Your support is crucial in ensuring that the voice of the community is heard, and the proposed development aligns with our shared vision for South Carthay.
